

## Potato Growers' Biosecurity Self-Evaluation Checklist

**Note:** The list does not contain all of the points you should consider in developing a biosecurity plan for your farming operation. As well, not all practices listed may be possible or appropriate for your particular farming operation. The level of risk will be determined by the size, diversity (e.g. variety of crops), and type of farm business you operate (e.g. seed, fresh, etc.). Refer to your National Farm-Level Biosecurity Standard and Planning Guide for additional aspects to review.
